6. Wash off all furniture used and return to original place.

8. Turn off all lights and fans.
9. Key(s) to facility should be given to a school official or the security guard on duty. He/she will lock doors and set alarm.
10. NO water on gym floors.
11. All trash must be properly disposed of in the **outside** garbage dumpster.
12. If an accident or damage occurs in the facility, the school principal or athletic director should be immediately contacted.
